 - Davidson Speech therapist app (K-6) \$54.99
 - Tami questioned what the district provides?
 - All teachers are using different things as supplemental online
 - **Jason Leander made a motion to approve the 4 grants: Stewart, Rogers, Newhard & Davidson for a total amount of \$2026.69. 2nd by Charlene Garcia. Motion carried.**

- Fundraising idea: Calendar Raffle
 - Pick one month
